MCAV CATTLEMEN'S CHALLENGE EVENT OVERVIEW

Preliminary Events

Cattlemen's Mounted Whipcrack

Senior riders must attempt to crack whip targets at a canter, junior riders must attempt to crack targets at a trot. Points based on accuracy, time and horsemanship.

Cattle Handling - This event is run in a similar style to a working cow horse event, with each competitor given a single beast which they will be required to work in an arena. Course details will be provided in the riders briefing.

Obstacle Course – competitors must negotiate a course with different obstacles designed to test both rider and horse. Competitors may have to complete sections of the course bareback. Points based on accuracy, negotiation of course and time. There will be a maximum time applied.

Dry Work Pattern – Dry work pattern that will include, but is not limited to, roll backs, lead changes and circle work. All entrants will be emailed the pattern before the event.

Final Event

Mountain Cattlemen's Challenge final – The final event for Open and Ladies competitors will see the best placed riders compete in two events – a time trial and a cow work. Junior riders will only compete in a time trial.

VET & GEAR CHECK

Gear check

Judges are entitled to disqualify any competitor or direct them to replace any gear deemed to be unsafe or unsuitable.

- Horse to be presented to the gear check judge fully saddled including bridle and breastplate.
- Rider to wear Australian Standard helmet (see below), vest (optional), stock whip, oilskin
- All gear must be in good, safe working order and must reflect the spirit of the Mountain Cattlemen.
- Gear will be checked on the appropriateness of use in mountain bush riding.
- All horses must have a breastplate fitted for the duration of the event.
- All riders must fasten a full-length oilskin to their saddle for the duration of the event (excluding any bareback components in the obstacle course or unless otherwise specified by the judge on the day). Alternatively you may wear your oilskin.
- All riders must have fastened to their gear a leather stockwhip for the duration of the event unless required to be used eg in the whipcrack or unless otherwise specified by the judge on the day.
- Horses, saddles and breastplates presented during the Vet and Gear Check will be marked and the same gear must be used in all subsequent events over the course of the event (including the final event).
- All competitors must have 2 points of contact to hold the saddle secure (girth and surcingles in addition to the breastplate. Back girth will not be accepted). Fender saddles are acceptable with a single point of contact.
- Standing martingales and/or tiedowns **must not be used** at any time.
- Helmets must comply with current Equestrian Australia standards and must not have been in an accident. Helmets must fit the rider correctly. Approved numbers:
 - ✓ Current Australian standard AS/NZS 3838 (2006 onwards) provided they are SAI Global marked.
 - ✓ New Australian standard ARB HS 2012 provided they are SAI Global marked.
 - ✓ Current American standard ASTM F1163 (2004a or 04a onwards) provided they are SEI marked.
 - ✓ Current American standard SNELL E2001.
 - ✓ Current British standard PAS 015 (1998 or 2011) provided they are BSI Kitemarked.
 - ✓ Interim European Standard VG1 (01.040: 2014-12) with or without BSI Kitemark.

Dress code

- Approved smooth soled riding boots must be worn.
- Collared shirt with long sleeves and appropriate riding trousers.
- All riders must wear an Equestrian Australia Approved helmet at all times whilst mounted.

Vet check – health and soundness of horse

- All horses must be free of any substance or drug that affects performance. The Committee reserves the right to test.
- Present unsaddled horse for vet check and standing heart rate measurement.
- Horses are to be fit and sound (eg not lame, girth-galled or saddle sore etc).
- The horse must be able to be led at a trot to the satisfaction of the Veterinary Practitioner, otherwise it will be disqualified.
- Should a horse be vetted out before the competition commences, the competitor may use a spare horse as long as it is presented to the vet for inspection prior to the completion of the Vet and Gear Check.
- Once the competition begins, the same horse must be used for all phases of the event.
- Any horse/s found to have a contagious disease will be subject to the rules of quarantine or removal from the grounds as determined by the veterinary practitioner.
- The Committee may require a vet check at the conclusion of any/all events if it is deemed necessary, including the Final.

Cattle Handling

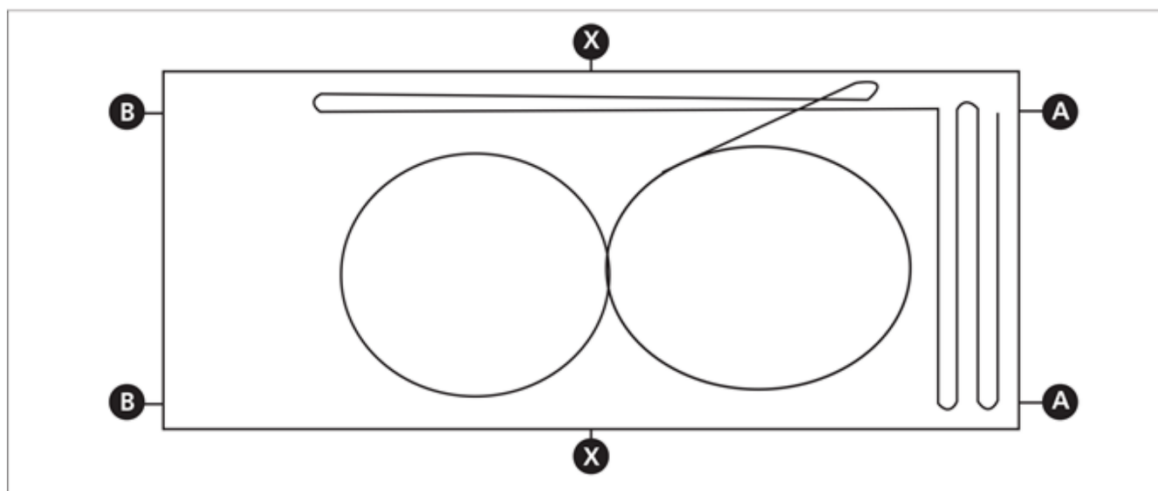
Event Judge: Sue Lind

Requirements

- Competitors will be allowed a set time to complete the pattern.
- Patterns will be provided in the riders briefing pack and can also be found below.
- Competitors are allowed to use a stockwhip to help guide their cow, but are not permitted to strike the animal.
- Should a competitor not finish before time, all points will count until the time mark.
- Judges can deem a beast "lost". This is signalled by the judge cracking a whip. No further course may be completed after this point.
- Horse and rider are required to control the movements of a cow down the arena fence and in the centre of the arena.
- Should a rider fall during the cattle handling and chose to re-mount a 20 point deduction will be incurred.
- All judges decisions are final.

AUSTRALIAN WORKING COW SECTION PATTERN

Competitor: _____ Horse: _____



1	After acknowledging judge, take beast to Southern short side of arena & perform a series of blocks, demonstrating control of the beast. A score for this section is out of a possible 20 points with points deducted for loss of a beast (recommended 5 points), with credit given to control and degree of difficulty on the cow.	20
2	Upon completing section 1, take beast down either long side of arena and perform 180 degree turn at any point past marker "X" and before marker "B". Points will be deducted for not performing turns between these markers. Where a beast is turned short of the "X" centre marker or past the "B" marker, the judge is again recommended to deduct 5 points for that section. Where a beast deviates off course a competitor is allowed to bring the beast back to the fence and attempt the maneuver again. Judges should look to deduct 2 points in this situation.	20
3	Upon completing section 2, take beast down fence and perform 180 degree turn at any point past marker "X" and before marker "A". Again, points will be deducted for not performing turns between these markers.	20
4	Upon completing section 3, take beast and perform a circle to the left or right (in either direction). Competitor may complete up to two circles in either direction in order to maintain optimum control and position on the beast. Credit points should be given for a neat flowing circle with tight position on a cow. "T-Boning" or dangerous riding will be heavily discounted or terminated as dangerous riding.	20
5	Upon completing section 4, take beast and perform a circle in the opposite direction. With points awarded for position and control of the beast throughout the circle. In summary, this section of the Australian Performance Horse Challenge is designed to showcase the Australian Performance Horse, with a strong theme to work a beast in a similar fashion to that of the Campdraft Competition.	20

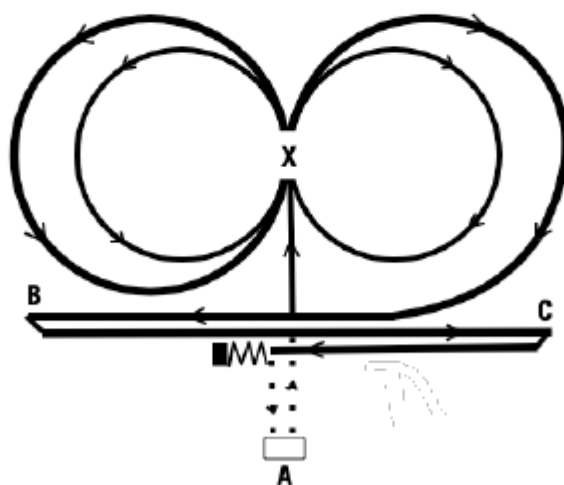
Requirements

- Competitors will be allowed a set time to complete the pattern.
- Patterns will be provided in the riders briefing pack and can also be found below.
- Competitors are required to carry a stock whip on their person/saddle at all times
- Should a competitor not finish before time, all points will count until the time mark.
- Judges can deem a horse control as "lost". This is signalled by the judge cracking a whip. No further course may be completed after this point.
- Horse and rider are required to complete the pattern as outlined.
- Should a rider fall during and chose to re-mount a 20 point deduction will be incurred.
- All judges decisions are final.

OBSTACLE COURSE

Event Judge: Elisa Grobe

Requirements

- Competitors are required to complete a set obstacle course designed to test both rider and horse, within a maximum time to be advised at event briefing.
- Course map will be available at the gate for viewing.
- Competitors shall walk the course with the judge prior to riding.
- Open riders must complete the obstacle course bareback. Ladies and Juniors who choose to ride the obstacle course in a saddle will have points deducted as per the below. Open riders **MUST** ride bareback.
- The competitor is to acknowledge the judge and judging begins the moment the judge indicated to the competitor to commence.
- There will no schooling from the time the horse enters the arena.
- An obstacle course may consist of the following variation of gaits: walk, trot, canter, fast canter and/or gallop, lead changes (simple or flying), at least one spin each way, one roll back each way, back up, stops, side pass, circles. There is also a wide range of obstacles to consider including bridges, gates, push or pull objects, water, fire, smoke, roping, ground tie and dinking a passenger. Not all of the latter may be used.
- The best obstacle course horse shall be willingly guided and controlled with little or no resistance. Points will be awarded for precision and accuracy.
- Points will be deducted for lack of precision, discipline, and quality of movements.
- Penalties will occur for incorrect manoeuvres. All deviations from the exact pattern must be considered a loss of control/course and will be marked down accordingly.
- There will be a total of 12 components to the course - 11 being obstacles and the 12th being an overall horsemanship score.
- Competitors will have 4 minutes to complete the course, a whistle will blow twice to finish if the 4 minute time is up. You will be scored for all obstacles completed until whistle is blown and also still be given a horsemanship score out of 10.
- There is a 5 point penalty for the use of a saddle in Ladies and Juniors. There is a higher degree of difficulty to do entire course bareback so that will reflect in this method of scoring ie it could be .5 to 1 point more per obstacle just for doing it bareback depending on how well the saddled rider executes each obstacle.
- The judging of each obstacle will be done on a points scale of 0 – 10 in 0.5 point increments, with 5.5 being considered an average score. There are three basic components to each obstacle: the Approach (maximum +1 or -1 point), the Obstacle itself (0 - 8 points) and the Departure (maximum +1 or -1 point). The purpose of this is to improve horsemanship and to allow the judge to provide a more accurate score for each obstacle, as well as pinpoint areas for improvement.

THE APPROACH

Every rider will start the approach with a score of 0, and receive quarter point increments or deductions, based on performance. Total points for the approach are not to exceed -1 or +1 point in this section.

The approach to any obstacle might involve a downward transition to a trot or walk from a lope or even a gallop. An emphasis will be placed on riding with a loose rein. The judge will be scoring on what happens when those loose reins are picked up to make a transition or start the manoeuvre.

The downward transition should be smooth, soft and balanced. The horse should be in a natural frame and willingly respond to cues from the rider. The horse should act as if it knows how to do the transitions, and that they are following the cues they were taught. The horse should not act as if being pulled down by strength, gaping its mouth, or throwing its head up in the air to resist to the point of

notice. The horse should not be swapping leads on the way in. The approach should be as straight as possible.

THE OBSTACLE

The rider shall start the obstacle portion with an average score of 5. A judge may award up to 3 additional points for the execution of the obstacle and may deduct to a score as low as 0. The maximum score of an obstacle shall be 8. Riders shall be awarded or penalized using half point increments as shown below.

After transitioning down to the appropriate safe speed, the horse should act as if it has seen and done the obstacle before and is looking to find their way through the challenge. On the obstacle, the judge is looking for a horse working on a loose or soft rein. For example, does the horse have a catty look with his head down hunting the obstacle? Does the rider know where the horses' feet are? Ideally, the horse and rider should look confident and relaxed. Again, horsemanship is always stressed as well as speed with control.

THE DEPARTURE

In the departure, the rider shall be awarded up to 1 point or deducted as much as 1 point depending on his performance done in ¼ point increases or deductions.

How the actual obstacle is accomplished will have a lot to do with how the horse and rider leave. If an obstacle went well, the EXCA would expect to see a smooth exit and an efficient line being established to the next obstacle. Like jumpers coming down from one jump while looking and lining their horse up for the next jump.

The upward transition should be smooth and on the correct lead for the line of travel. Leads are really important here but may not always happen within the parameters of the obstacle. A lot of riders trot out and acquire the new lead on the way to the next obstacle. That correct or incorrect lead will be judged in the overall horsemanship category.

Balance, cadence and confidence are what the EXCA wants to see coming into and out of obstacles. Smoothness up and down through the gait transitions, similar to automatic transmissions, rather than four speeds with popping clutches.

Penalties (-1/2) point per incident

- Incorrect lead
- Gaping mouth
- Not changing in the back during a lead change (cross firing)
- Excessive spurring
- Hanging or balancing on the reins to maintain balance
- Going too fast when conditions make the footing unstable
- Being heavy handed
- Having excessive speed going into an obstacle
- Not keeping the horses' hind inside leg planted during a turn around
- On a turn around, hopping and not crossing over correctly on the front end

Awards (+1/2) point per incident

- Starting on and maintaining the correct lead
- Riding on a loose rein
- Keeping horses' hind inside leg planted during a turn around
- On a turn around, showing speed and crossing over in front without hopping
- Big sliding stop, without pulling on the horses' face, causing gaping mouth and head elevation
- Good speed control with lots of rate

Backing through an obstacle with straightness, cadence and speed while having the horse bridled up and broke at the poll

Keeping the horse collected and correct throughout the obstacle maintaining proper framed body

- A score of 8 or 9 indicates the horse rider team had an outstanding Approach, Obstacle and Departure.
- A perfect ride and a score of 10 is extremely rare.
- Each obstacle shall have a 30 second time limit. The time begins when the rider engages the approach of the obstacle.
- If the time limit elapses, a whistle will be blown and the rider must move on to the next obstacle. The judges may allow the rider to continue provided the horse/rider team was making substantial forward progress toward completing the obstacle when the whistle was blown.
- If the rider does not complete the obstacle, points will be given or deducted based on his/her attempt. A valid attempt may be scored from .5 – to 2 points. The judges shall not give a 0 (zero) if a valid attempt is made.
- If a rider skips an obstacle and begins the next obstacle (example: the rider completes obstacles 1 – 4 and skips obstacle 5 and begins obstacle 6) he/she may not go back to the obstacle that was skipped.
- The rider will receive a score of 0 (zero) for the missed obstacle.
- An overall horsemanship score will be awarded to every rider regardless to how many obstacles he/she completes. This is scored from 1 to 10 in 0.5 point increments. This can be viewed as smooth communication between horse and rider.
- Judges shall pay particular attention to the rider's balance, cadence, soft hands (loose reins), the use of their legs and seat and speed with control. Judges shall pay attention to the horse being on the correct lead going into an obstacle and leaving an obstacle as they move toward the next obstacle.
- Should a rider be bucked off or fall off, he/she may continue to compete provided he/she can catch their horse unassisted and remount within one minute. A penalty will be incurred.
- Time is also taken into account. In the event of a draw the rider with the faster time will take the higher placing.
- Riders must complete the course by themselves with no outside input. Juniors, Cattlekids and Poddies are excluded from this rule.

CATTLEMEN'S MOUNTED WHIPCRACK

Event Judge: Emiliqua East

Requirements

- Open and Lady riders are to ride the course at a canter (minimum).
- Junior riders are to ride the course at a trot (minimum).
- Competitors must attempt to cleanly cut a set number of targets with a forward style cattlemen's crack. Whip must crack to achieve the points for that target.
- Only one attempt is permitted for each target.
- Competitors are not permitted to stop to attempt a target.
- Should a rider fall whilst completing the course, they will incur a 20 point deduction.
- Should a rider fall, all points will count up until the fall.
- Riders are not permitted to ride outside of the designated course boundary to cut or negotiate a target or obstacle.
- Should two riders achieve the same total score, the fastest time on the course will be announced the winner of the Cattlemen's Mounted Whipcrack.

Mounted freestyle

- Competitors are to conduct a mandatory 30 seconds freestyle on their horse.
- Competitors may use two whips.

Freestyle is to be completed after the Whipcrack Course.

MOUNTAIN CATTLEMEN'S CHALLENGE FINAL

Requirements

- All Top 6 Open, Top 6 Lady and Top 6 Junior riders will walk the final course prior to the event being run.
- All Top 6 Open, Top 6 Lady and Top 6 Junior riders will carry their preliminary events scores forward into the Final.
- The highest scoring rider (from the 4 preliminary events and points combined) will be announced the Mountain Cattlemen's Challenge Overall Winner in each category (Open, Ladies & Junior).
- All riders must be in control of their horse and demonstrate good horsemanship at all times whilst on course.
- Should a rider fall whilst completing the course, they must **not** re-mount and continue.

Riders

1. All adult riders competing in the Open or Ladies Cup must be a minimum of 18 years of age.
2. Any rider under the influence of drugs or alcohol must not, and will not, be permitted to take part in the event.
3. A rider must not ride dangerously, compromise the welfare of a horse or another competitor.
4. Any rider who has a fall from a horse whilst in warm up or competing must have a medical examination and be declared fit to ride by the designated first aid officer before riding in any further events during the weekend. The only exception to this is those that fall and land on their feet or fall during an event and opt to continue.
5. All riders must treat the animals they interact with humanely and obtain prompt veterinary assistance if a horse or any other animal they are in charge of becomes ill or injured.

Gear

All gear, including helmets, will be inspected at the compulsory Vet and Gear Check prior to commencement of the event and must be in good repair, properly fitted and must not cause discomfort or injury to the horse. See Gear Check section.

In addition:

1. All horses that are shod must have correctly fitting shoes. Shoes must not be worn that have nails protruding or clenches risen. Toe grabs must not be used.
2. All bandages must be stitched.
3. Spurs are permitted.
4. Riders must have a stockwhip secured at all times during all phases of the event (cattle handling, obstacle course, whipcrack, dry work and final) and are permitted to use it when required or as directed with good horsemanship as a guideline. Riders may elect to hand carry their whip but it is not compulsory.
5. Riding crops are not permitted at any time.

Other

1. All competitors must hold a current Ambulance Membership cover and must have paid for their event in full prior to commencing competition.

2. All competitors must indicate they have read and accept the Acceptance of Risk on the online Entry Form. This is a form to be downloaded and signed by a parent or guardian if the competitor is under the age of 18.
3. Entries will be taken from July 1. Entries are accepted on a first in best dressed system, with a rider considered accepted when all forms have been signed and returned to the MCAV and all fees paid.
4. All competitors are to treat Mountain Cattlemen's Association of Victoria Committee Members, Horse Event Coordinators, Judges, Stewards, Volunteers or any single person associated with the coordination of the event with respect at all times.

Prizes

There will be a sash presented to the winner in all Cattlemen's Cup sections – obstacles, whip crack, cattle, drywork and the Final.

COMPETITION RULES

Any Competitor or Member using electronic technology to defame the Mountain Cattlemen's Association of Victoria, the Annual Get Together, Cattlemen's Cup, Volunteers, Staff, Stewards, Judges or other Competitors will be disqualified from the Mountain Cattlemen's Cup Challenge and this will affect future inclusion in the event.

The Mountain Cattlemen's Association of Victoria endeavour to hold a fair and enjoyable event for all competitors; however it is understood that changes may be made to the event at the last minute to ensure the riders and competing horses' safety. All competitors acknowledge when they enter the event that they will accept **any and all** changes and decisions made by the MCAV or MCAV Staff, Volunteers, Vets, Stewards or Judges.

All competitors will abide by the following Competition Rules:

1. The event will be run over three days including Vet and Gear Check on Friday.
2. The Committee reserves the right to make changes to the program in the event of extreme circumstances altering ride times, durations and/ or cancelling event sections. No refund will be given.
3. Entries will be taken from June 17.
4. Riders must accept any decision made on the appropriateness/fitness of a horse to compete by the Event Veterinary Practitioner.

5. Open and Lady riders must be 18 years and older on the day of the event commencing. Junior riders must be between the ages of 14 and 17 the day of the event commencing. The parent or legal guardian must sign the Acceptance of Risk for the Junior rider to be eligible to participate in the event.
6. All Open, Lady and Junior competitors must wear an Equestrian Australia Approved Helmet at all times whilst mounted. See Gear Check.
7. Each competitor is permitted one and the same horse for the duration of the event.
8. Riders must be experienced and accomplished competitive riders with an appropriately trained horse capable of undertaking the challenging conditions of this event. Chief judges of each of the pre-race stages, in consultation with Horse Committee, have the authority to eliminate any rider from competing in the race if they feel that the skill of horse and rider together is not at standard and would be potentially unsafe.
9. Riders must conduct themselves in a fair and friendly manner towards all Staff, Volunteers, Judges, Vets, Stewards and other Competitors at all times.
10. Riders must accept any and all changes made to the event as necessary as set out by the MCAV Cattlemen's Challenge organisers. Riders must accept any decision made in regards to scores and rules/regulations by the Judge and/or Stewards of the MCAV Cattlemen's Challenge.
11. Should a rider's horse become ill or injured, competitors must seek the necessary veterinary assistance as soon as reasonably possible. Payment of the necessary veterinary services is the rider's/horse owner's responsibility.
12. Any animal deemed unfit or at risk by the MCAV Cattlemen's Challenge event organisers, or the MCAV Veterinary Practitioner will not be permitted to continue in the competition. All decisions are final and no competitor is permitted to enter into any discussion once a decision has been made.
13. Mistreatment or cruelty to any animal in the competitor or another's care will result in the person/s responsible being asked to leave the event immediately and not invited to attend the event again. Other penalties may include: disqualification, loss of points and/ or any prize money awarded.
14. All Open and Lady Cattlemen's Cup riders enter with the intention of riding in the Open or Lady Final should they progress through to the Top 6 Open or Top 6 Ladies.
15. All Junior Cattlemen's Cup riders enter with the intention of riding in the Junior Final should they progress through to the Top 6 Juniors.
16. All riders will be notified of their acceptance into the Cattlemen's Challenge. Any rider put on a waiting list will also be notified. Anyone not accepted will receive a full refund.
17. All competitors must have current Ambulance Cover to ride in the Mountain Cattlemen's Challenge.
18. All competitors must register at the Riders Registration which takes place before the event commences at the Event Secretary's Office.
19. All competitors must attend the Riders Briefing which takes place on Friday evening. Times will be confirmed.
20. Any Open, Lady or Junior rider who elects not to ride in the final event must notify the Horse Event Organisers as soon as practically possible after the Top 6 Open, Top 6 Lady and Top 6 Junior announcement on Saturday night.
21. All riders enter at their own risk with no responsibility accepted by the Mountain Cattlemen's Association of Victoria for riders, livestock or property.
22. Any and all decisions made by the Judges, Vets, MCAV Committee or Horse Event Organisers are final and no discussion will be entered into.
23. If a rider wishes to lodge an event/scoring/judging review, they must attend the Event Secretary tent and fill in the appropriate form within one hour of scores being released. Any rider who wishes to lodge a formal complaint will be charged a \$100 fee. If the complaint is deemed not valid 40 points will be deducted from the riders score. Should the Committee find that the dispute is genuine and in favour of the disputing rider, the fee will be refunded.
24. Any rider who lodges a complaint under rule section 23 will have their complaint reviewed.
25. Any rider or support person (family member, friend or associate) found interfering with judging, scores, event equipment, livestock or other competitors will be asked to leave the event immediately and will forfeit any prize/s or points awarded.
26. The MCAV reserves the right to vet check any horse post event. If the horse is found to be unduly stressed by the veterinary officer on the day, that horse will be eliminated.
27. In the event of a tie for first place in the Open, Ladies or Junior Cattlemen's Challenge, the winners will toss for prizes and the prize money will be split between the two competitors.

28. Each of the 4 preliminary events will be judged individually with the Top 6 highest scoring Open, Top 6 Lady and Top 6 Junior riders going forward into the Open, Ladies and Junior Mountain Cattlemen's Challenge Final held on Sunday.
29. Presentation of Finals prizes will take place after the final event.
30. Scores awarded for each of the preliminary events will be posted as soon as possible after completion of that event.
31. No individual event scoring will be released to riders except at the event organisers discretion.
32. Consumption of alcohol/drugs and smoking is not permitted whilst competing or during the presentation of awards.
33. A lady aged 18 years or older may elect to enter into either the Open or the Ladies challenge, however is not permitted to change categories during the event regardless of what position they may hold in the overall standings.
34. Refunds /scratchings - Scratching will incur a 20% administration fee. Any scratching after October 15 will not receive a refund unless accompanied by a vet or doctor's certificate or at the MCAV's discretion.
35. Criteria for acceptance. All entries must be done online. This can be done via the website www.mcav.com.au. If you are having trouble, enlist help. You can also contact the MCAV office for assistance on 0407 520 309 or email secretary@mcav.com.au.
36. Open Riders. Entries capped at 20, 5 emergencies. The MCAV reserves the right to include all 25 competitors in the Event. The top 6 placed riders will be eligible for the Final. If anyone withdraws, the next qualified person may replace.
37. Age for Junior Category. Junior riders must be 14 and under 18 on the day of competition. Total entries capped at 20. The MCAV reserves the right to include all 25 competitors in the Event. The top 6 placed riders will be eligible for the Final. If anyone withdraws, the next qualified person may replace.
38. Ladies competitors are 18 and over on the day of competition. Total entries capped at 20. The MCAV reserves the right to include all 25 competitors in the Event. The top 6 placed riders will be eligible for the Final. If anyone withdraws, the next qualified person may replace.
